# **Tuition Refund**

#### One-payment plan

(Tuition paid in full by July 1)

July 1 payment is 50% refundable, if student withdraws from school for any reason on or before October 31, otherwise it is non-refundable.

#### Two-payment plan

(Tuition paid on July 1 and January 1)

July payment is 50% refundable, if student withdraws from school for any reason on or before October 31, otherwise it is non-refundable. January payment is non-refundable.

#### Monthly payment plan

Monthly payments are non-refundable.

St. Michael School cancels bank drafts through FACTS once a student withdraws.



#### **Tuition**

A non-refundable deposit of \$250 per child is required at the time of registration. This deposit is not an additional fee, but will be deducted from tuition.

#### Fees

#### Handling Fee

A \$35 handling fee is charged to all accounts in arrears. This fee applies only to those who do not use the *FACTS* payment plan.

## **Tuition Schedule Categories**

Parishioners of St. Michael, St. Mary, Stonington, St. Patrick, Mystic, and St. Thomas More, N. Stonington

Parishioners of the above names parishes qualify for the "Parishioner Rate" provided that they are practicing Catholics formally registered in their parish, and contribute a minimum of \$8.00 per week to their church in the offertory by envelope, check or EFT. These conditions must be met for one full year in order to qualify for the parishioner rate. Catholics who do not meet these requirements will be charged the Non-Parishioner rate.

#### Non-Parishioners & Non-Catholics

Catholics who belong to parishes other than those listed above are charge the tuition rate for *Non-Parishioner* outlined above. In the Diocese of Norwich, Catholic parishes without a parish elementary school are required to subsidize the education of each parishioner attending a Catholic school in the amount of \$1000 per child, \$750 of which is applied to tuition payment. In order to receive this tuition assistance you must have your pastor sign the green *Parish Affiliation Form* and return it to St. Michael School. The school will bill your parish and the payment will be credited to your account.

In some instances, non-Catholics have received assistance from their own churches, so you may want to inquire as to whether your church will assist you by subsidizing tuition. If this is the case, then please fill out the *Parish Affiliation Form.* Any payments received from your church will be credited to your account.

## Payment Plans

Option 1 – Full Payment

Under this payment plan, tuition is due in full by July 1, 2025. A 3% discount is given for full payment by July 1.

#### Option 2 – Semester Payments

Under this payment plan, tuition is paid through the *FACTS Tuition Payment Plan*. in two equal installments. The first is due July 2025 and the second by January 2026.

#### Option 3 – Monthly Payments

Under this payment plan, tuition is paid through the *FACTS Tuition Payment Plan*. Tuition is paid in ten (10) equal monthly installments paid July 2025 through April 2026. Payment dates are the 5th or 20th of each month. Please refer to the *FACTS* brochure for more information.
